

1 CONSENT OF BIRTH FATHER TO ADOPTION

3 I, JUSTIS CHAD WILLIS, the undersigned, born on July 17, 1994, who currently resides
4 at 1348 North Doral, Mesa, Arizona 85205, being the birth father of AUBREY LYNN LEE born
5 on December 17, 2011 at 2:38 p.m., in Mesa, Maricopa County, Arizona, do hereby relinquish
6 all of my rights to the care, custody and control of said minor child, to SCOTT and SIRRINNA
7 PABIN, a married couple, for the purpose of adoption. I have been furnished with all of the
8 information I wish to know about the adopting parent, SCOTT PABIN. I hereby acknowledge
9 that SIRRINNA KAY PABIN a.k.a. SIRRINNA KAY LEE is the Biological Mother of said
10 minor child. SCOTT PABIN is her spouse and will be adopting AUBREY LYNN LEE.
11

12 I further state that this Consent for the adoption of the minor child is being executed more
13 than seventy-two (72) hours after the birth of the minor child, and that this Consent is executed
14 by me freely and voluntarily and without duress, coercion, undue influence or through threat, and
15 I am acting in a sound mind and memory.
16

17 I understand that this Consent is irrevocable and that I cannot change my mind; I am
18 aware that the Consent to Adoption cannot be withdrawn without a Court Order.
19

20 I understand that as a result of executing this Consent to Adoption, the parent-child
21 relationship between the above-named minor child and me shall, upon the entry of a decree for
22 adoption, be terminated and that all the legal rights, privileges, duties, obligations, and other
23 legal consequences of the parent-child relationship will cease to exist under A.R.S. 8-117. The
24 only rights which continue are the right of inheritance and support which will terminate upon the
25 entry of the decree of adoption. I understand that an action to terminate my parental rights can
26 be initiated under A.R.S. 8-533 based upon this Consent.

1 I do, in fact, give my consent freely and voluntarily and without duress of any kind
2 whatsoever, and realize that this Consent, once given, is final and cannot be withdrawn except
3 where obtained by fraud, duress or undue influence.
4

5 I state that I am not a member nor eligible for membership in an Indian Tribe. I am not
6 currently nor have I ever been a resident of an Indian reservation. To the best of my knowledge,
7 the above-named minor child is not eligible for enrollment in an Indian Tribe.

8 I further consent to and authorize SCOTT and SIRRINNA PABIN to have the right to
9 consent to necessary medical procedures for the child, and to have the responsibility to provide
10 proper care and support of the child.
11

12 I have been advised of the consequences of the Consent, including the consequences
13 pursuant to A.R.S. Section 8-106, pertaining to the irrevocability of the Consent, and A.R.S.
14 Section 8-117, pertaining to the rights under an adoption order, and A.R.S. Section 8-114, which
15 prohibits any direct or indirect compensation to be given to me for this Consent. I further
16 acknowledge that I have been informed that I may receive no financial assistance of any sort in
17 return for signing this consent except as permitted in A.R.S. 8-114.

18 I submit to the jurisdiction of the State of Arizona and acknowledge and agree that all
19 matters relating to the adoption of the child shall be determined in accordance with the laws of
20 the State of Arizona.
21

22 If I am in the armed services of the United States at this time, that fact in no way has
23 interfered with my freedom to make my decision to execute this Consent, and, insofar as this
24 matter is concerned, I waive all rights, privileges, and exemptions existing or that may hereafter
25 exist in my favor under the Soldiers' and Sailors' Civil Relief Act of 1940, including the
26 appointment of counsel to represent me in this cause.

28 I have authorized and approved this adoption because I believe it is in the best interest of
the child.

1 I further expressly waive all notice of any further Court proceedings in connection with
2 the adoption of the minor child and I expressly waive all notice of any further court proceedings
3 in connection with any termination of parental rights proceedings.
