

1 WAIVER OF NOTICE AND APPEARANCE BY BIRTH FATHER

2 I, JUSTIS CHAD WILLIS, am the biological father of AUBREY LYNN LEE born on

5 I have heretofore given my Consent to Adoption of said child.

6 I do hereby voluntarily and unconditionally waive all my rights to receive notice and to  
7 appear in any and all hearings or proceedings held in connection with or pertaining to the  
8 severance of parental rights, the adoption, or any other proceeding pertaining to the health or  
9 welfare of said child.

11 I understand fully and clearly that this waiver means that I will not be notified of any  
12 hearings or proceedings to be held in connection with the severance of parental rights, the  
13 adoption, or any other proceedings pertaining to the health or welfare of my child and that my  
14 attendance will not be required or expected, nor will my absence be of any consequence  
15 whatsoever and that in spite of the fact that I am now the father of the child, any hearings or  
16 proceedings can take place without my being there, and that the result of the hearings and  
17 proceedings can be, and most likely will be, that all my rights, privileges, duties, obligations,  
18 relationships and contacts with my child will be completely severed. I understand that I have a  
19 right to appear as a party in a termination of parental rights action in Arizona. I understand that  
20 the failure of a parent to appear at the initial hearing, the pretrial conference, the status  
21 conference or the termination adjudication hearing may result in a finding that the parent has  
22 waived legal rights and is deemed to have admitted the allegation in the petition for termination.  
23 I understand that the hearings may go forward in the absence of the parent and may result in the  
24 termination of parental rights based upon the record and evidence presented.

1 I understand fully and clearly that this waiver means that I will not be notified of any  
2 hearings or proceedings to be held in connection with the termination of parental rights, the  
3 adoption, or any other proceedings relating to the health or welfare of my child and that my

5 whatsoever and that in spite of the fact that I am the biological father of the above-named minor  
6 child, any proceedings can take place without my presence, and that the result of the hearings  
7 and proceedings will likely be a termination of my rights, privileges, duties, obligations,
